## D2a. Report from CARMA Long Range Planning & Board of Directors Meeting

Conor Boughey and Rene Mendez, CARMA's Primary Representative, provided an update from the CARMA Long Range Planning & Board of Directors Meeting. They reported that CARMA, which provides excess liability limits to 5 pools is well funded and is looking into making dividend payments to the underlying Members.

## D3a. Report from ERMA Board of Directors Meeting

Brett Miller, ERMA's Primary Representative provided an update from the ERMA Board of Directors Meeting. He stated that there are new Members and the Long Range Planning will be held the following week.

## D3. UNFINISHED BUSINESS

## D3a. Report from Long Range Planning

Conor Boughey updated the Board on the items discussed from the November 29, 2018 Long Range Planning, which the Board took action during the November 30, 2018 Board Meeting held the following day.

Firstly, the City of Del Rey Oaks Police Department has expanded their services to the Monterey Airport effective October 1, 2018. At the November 30, 2018 Board Meeting, the Board took action to charge the City additional premium based on the formula without the cap increased payroll calculation. Since then, MBASIA has received the additional premium payment.

Secondly, during the Long Range Planning, the Board had a lengthy discussion between the difference of the Alliant Property Insurance Program (APIP) and Alliant Motor Vehicle Program (AMVP). At the November 30, 2018 Board Meeting, the Board made a motion to prohibit Members from insuring their autos through APIP and to continue insuring the autos through AMVP. The Program Administrators sent out an email to the Board reminding the Board that they can schedule mobile/contractors equipment on either APIP or AMVP and what is needed for each program.

Lastly, the next Police Risk Management Committee Meeting is on Monday, April 8, 2019 at 11:30 AM held at the Alliant Salinas Office. The Board suggested that Vince Hurley attend the meeting to discuss SB 1421 Peace Officers: Release of Records, which allows public access to police records in cases of force.

## D3b. Excess Workers' Compensation Renewal

Conor Boughey noted that the Version 2 CSAC EIA renewal estimate as of December 2018 is included in the agenda packet. MBASIA is a member of CSAC EIA's Excess Workers' Compensation program with a \$250,000 Self Insured Retention. The next estimate, Version 3 will be provided at the April 2019 Board Meeting.

Also, to keep Rene Mendez as CARMA's Primary Board Member and appoint Layne Long as the Alternate; and keep Brett Miller as ERMA's Primary Board Member and appoint Dino Pick as the Alternate.

# D4b. CSAC EIA: Excess Workers Compensation Coverage Item: Off-Duty Peace Officer Injury (AB 1749) Endorsement

Conor Boughey reported that CSAC EIA has drafted an endorsement to the Excess Workers' Compensation (EWC) Memorandum of Coverage (MOC). The endorsement provides that the EWC MOC does not currently provide coverage for injuries that occur to off-duty peace officers while outside the State of California when the officer is not acting under the immediate direction of his or her employer unless: (1) The peace officer was engaging in the apprehension or attempted apprehension of law violators or suspected law violators, or in protection or preservation of life or property, or the preservation of the peace; and (2) Prior to the occurrence, the Governing Board of the member has adopted a resolution, as provided for in California Labor Code Section 3600.2, subdivision (b)(4), accepting liability for such injury.

The endorsement will provide coverage for such claims if the Member has adopted a resolution describing the circumstances under which the Member will accept liability for such claims. The Member does not need to provide the resolution to the EIA upon adoption. Instead, if a claim arises that the Member chooses to accept pursuant to its resolution, then the Member at that time will provide the EIA with a copy of the resolution. If approved by the EIA Board, the endorsement will be in effect for any claims that arise after the date the endorsement is approved by the EIA's Board of Directors.

## D4c. Liebert Cassidy Whitmore Employment Relations Consortium 2019 Agreement

Conor Boughey reported that the contract for the Liebert Cassidy Monterey Bay Area Employment Relations Consortium is up for renewal. The Cities of Capitola, Greenfield, Hollister, Marina, Sand City and Soledad are members of the Liebert Cassidy Employment Consortium and have direct access to their representatives.

A motion was made to approve the 2019 Liebert Cassidy Whitmore Employment Relations Consortium agreement.
