D1. Draft 2021-22 Liability Budget – 2nd Review

Conor Boughey reported that at the April 2021 Board Meeting, the draft Liability Budget was presented at the 75% confidence level. Also, the excess liability market is very challenged, and insurance options being presented to CARMA, which is MBASIA's excess liability pool involve significant rate increases, new aggregate limits (4x per layer).

A motion was made to recommend to the Board at the June 2021 Board Meeting to move the confidence level back to 70% because of the increases in the CARMA budget and accept the budget as final. The goal for FY 22-23 is to increase the confidence level to 75% from 70%.
