D4. King City Membership in MBASIA

The Administrators are waiting to receive a letter back from the City of King's Mayor stating that they understand how much they will owe the Board when they leave MBASIA. Members expressed concern that it is unclear how much the City will owe. Conor Boughey explained that per documentation provided to the City, they will owe roughly \$2.6 million. Michael Simmons explained that there was a meeting held with the City explaining the amount that will be owed in detail. Renee would like the letter from the City to specifically state that the City owes MBASIA \$2.6 million by July 1, 2016 and that the amount is non-negotiable.

The Members would like to get a letter that is specific, and that states exactly what the City is going to do, and acknowledge the specific costs of leaving the Pool.

Members gave direction to the Administrators to compose a letter to the City of King which states that the Mayor acknowledges exactly how much money will be owed to the Pool by the City, the first installment being due August 2016.
