C1. Annual Police Training Services

Conor Boughey reported that Greg Fox presented to the MBASIA Cities' Police Departments on the Use of Force, AB392 and SB 230 at the City of Hollister's Police Training Room and virtually (via Zoom) twice in February 2021. The first training was for the Supervisors/Management and the second training was for everyone else in the Police Department.

The MBASIA Board had its Board Meeting in early April 2021 and some of the City Managers reported positive feedback. The Board suggested an annual training from Greg Fox for the Police Departments.

At today's meeting, the Police Chiefs provided feedback that the Departments liked how convenient the training was via Zoom.

Direction was given to the Program Administrators to report back to the Board that the Committee wants at least an annual training with Greg Fox and anyone else that he recommends. Sometimes, the Police Departments may need for more than one training because laws are changing rapidly.
