# D1. 2016-17 Liability Budget

Conor Boughey reported on the liability budget methodology, proposed funding levels and difference budget scenarios. The Committee discussed the different funding levels, potential impacts on members and the current condition and funding within the liability program.

Direction was given to the Program Administrators to focus the liability budget renewal on a claims fund of \$1.2M including King City in the budget, and \$1M without King City.

# D2. 2016-17 Workers Compensation Budget

Conor reported on the budget methodology and the several different scenarios that were provided to the Committee Members. Conor asked for feedback regarding the level of funding for the budget, aiming to increase the confidence level funding to at least 60%.
