D. BOARD OF DIRECTORS

D.1.a. King City Membership Status

Conor Boughey explained that the EC met on January 26, 2016, and did not take action at the meeting. Currently the City has until March 1, 2016, to give notice of withdrawal. If the City does not give notice, the Board has until April 1, 2016 to give notice of involuntary withdrawal to the City.

Steve Adams gave a presentation to the Board of Directors explaining the City of King's position. He asks that at this point, that the pool give the City a one-year extension on a probationary basis.

Jamie Goldstein thinks it would be prudent to get a third-party to take a look at the situation at the City of King before taking any action. Steve asked if there is an option to have someone look at it that isn't Bill Cogbill. The Administrators explained they would have to research it.

Layne Long says he is not ready to make a decision today, but he would be interested in Bill Cogbill's thoughts as the Board is very reliant on his study of the City's Police Department. There have been many changes and his input on the current situation would be valuable. The City should be responsible for payment to Bill for this study.

Motion to ask Bill Cogbill to take a look at the City/Department and if he agrees to it and bring this issue back to the Board before April 1, 2016 to make a final decision.

He explained that there is an open item about how many years of loss history should be in the calculation. The benefit is that there ware fewer swings with a longer history, but the negative is that bad years linger longer.

Action is needed to determine how the budget committee should move forward.

Daniel Dawson asked how many years other pools use. Conor explained that it is between 5 and 7 years.
