Steve Adams of the City of King explained that the City has spent a lot of time with Bill Cogbill for the purposes of the review. The City has made a lot of changes, as outlined in Bill's positive review, but acknowledges that there is still a long way to go. Among the next steps, the City is once again in the process of hiring a new Police Chief. They have received many qualified applications for the position and are in the process of reviewing them. A hiring decision is expected in April, and Rene Mendez is on the review committee.

Jamie Goldstein commented that the City has made a lot of progress in a short period of time, and he compliments the new management at the City. He expressed that he is prepared to support another year of membership, and supports having a conversation about the SIR.

Conor inquired as to when the State's audit report is expected? Steve answered that it is expected in June.

A motion was made to continue the City's Membership for one year with the SIR remaining at \$250,000 for all losses related to the police department, and \$25,000 for all other losses. The SIR will be revisited in one year.
