### D3b. CARMA Insurance Renewal

Conor Boughey reports that there is approximately a 7% increase in this year's renewal with CARMA. This is a result of increased payroll and a higher claims experience. The renewal is \$422,000 for excess coverage for \$30,000,000 in coverage.

### D3c. ERMA Insurance Renewal

Conor Boughey reports that there is a 7.7% increase. The experience modification factor is 1.25, which is the max. MBASIA has very high claims per amount of payroll in this group.

# D3d. CSAC-EIA Insurance Renewal

Conor Boughey reports that this is a favorable renewal, despite a large increase in payroll. This group received a large credit for over-reporting payroll and will likely again receive one next year.

Daniel Dawson would like to review this coverage at the Long Range Planning Meeting.

Conor reports that there really isn't a viable option to consider besides CSAC-EIA in the State of California.

# D3e. APIP Insurance Renewal

Conor Boughey explains that some, but not all, MBASIA members are part of APIP. APIP is the largest property placement in the world. This coverage includes cyber liability and pollution coverage. While premiums have gone down, coverage has increased slightly, mostly for pollution.
